20 Protestant, [enter Protestant's name], files this protest under the provisions of California Vehicle  
21 Code section 3070(a) and alleges as follows:

22 1. Protestant is a new recreational vehicle dealer selling [enter line-make] and is located at

24 2. Respondent distributes/manufactures [enter line-make] products and is the franchisor of  
25 Protestant.

1           4.       On or about [enter date], Protestant received from Respondent a notice that Respondent  
2 intends to terminate its existing franchise effective 60 days from Protestant's receipt of said notice.

4           5.       Protestant generally denies each allegation asserted in the notice stated to be reasons for  
5 termination.

6           6.       Respondent does not have good cause to terminate the franchise considering the existing  
7 circumstances as stated in Vehicle Code section 3071. These circumstances include but are not limited to  
8 all of the following:

9           (a)       Amount of business transacted by the franchisee, as compared to the business available to  
10 the franchisee.

11           (b)       Investment necessarily made and obligations incurred by the franchisee to perform its part  
12 of the franchise.

13           (c)       Permanency of the investment.

14           (d)       Whether it is injurious to the public welfare for the franchise to be terminated.

15           (e)       Whether the franchisee has adequate new recreational vehicle sales and, if required by the  
16 franchise, service facilities, equipment, vehicle parts, and qualified service personnel to reasonably  
17 provide for the needs of the consumers for the recreational vehicles handled by the franchisee and has  
18 been and is rendering adequate services to the public.

19           (f)       Whether the franchisee fails to fulfill the warranty obligations of the franchisor to be  
20 performed by the franchisee.

21           (g)       Extent of franchisee's failure to comply with the terms of the franchise.

22           (h)       Other circumstances that would support the claim that there is not good cause to  
23 terminate Protestant's franchise.

24           7.       Protestant and its attorney(s) desire to appear before the Board and estimate that the  
25 hearing in this matter will take [enter number of days] days to complete.

26           8.       A Pre-Hearing Conference is requested.

1 WHEREFORE, Protestant prays as follows:

2 1. That the Board (or its authorized representative) immediately advise Respondent that a  
3 protest has been filed;

4 2. That a hearing of the Protest is required pursuant to Vehicle Code section 3080; and,

5 3. That, pursuant to Vehicle Code sections 3070 and 3071, Respondent may not terminate or  
6 refuse to continue the franchise unless and until the Board finds that Respondent has established good  
7 cause for such action.
