Farm vehicles, farm tractor, all-terrain or utility-terrain vehicle used exclusively in agricultural operations, or shade trailer	Vehicle Code §§ 400(c), 36005, 36101, 36102, 36105
Implements of husbandry	Vehicle Code § 36100
Special construction equipment and special mobile equipment	Vehicle Code §§ 565, 575, 4010
Cemetery equipment, forklift trucks, logging vehicle, and aircraft refueling vehicle,	Vehicle Code § 4012, 4013, 4018, and 4021
Electric bicycle, motorized bicycle, moped, or pedicab	Vehicle Code §§ 312.5, 406, 467.5, 4020

<sup>&</sup>lt;sup>1</sup> Terminal tractors (yard tractors), electric, and low speed vehicles are within the Board's jurisdiction if certified with equipment that would enable them to be registered with DMV for use on the public highways including streets.

<sup>&</sup>lt;sup>2</sup> A "motorcycle" is a motor vehicle having a seat or saddle for the use of the rider, designed to travel on not more than three wheels in contact with the ground.

<sup>&</sup>lt;sup>3</sup> A "motor driven cycle" is any motorcycle with a motor that displaces less than 150 cubic centimeters.

<sup>&</sup>lt;sup>4</sup> Truck campers are not registered by DMV and are therefore excluded from the Board's jurisdiction by statute.

<sup>&</sup>lt;sup>5</sup> Park trailer manufacturers and distributors are licensed by DMV but their products are not registered; therefore they are excluded from the Board's jurisdiction by statute.
